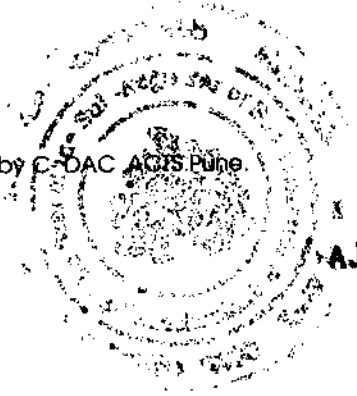

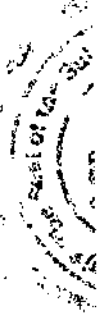



WHEREAS it was necessary to establish the Trust for the Promotion of Education of the Children and the Public, particularly belongs to Backward Communities and Minority Communities.

WHEREAS the Trustees have accepted the objects envisaged hereunder and agreed to act as Trustees to fulfil the objects of the Trust.

NOW, THIS TRUST WITNESSETH AND DECLARES AS FOLLOWS:

1. This trust shall be called "SRI KRISHNA INDIRA EDUCATIONAL & CHARITABLE TRUST" declared by the above joint authors and they have agreed to work as Trustees and to develop the same.
2. This Trust shall be constituted and administered in accordance with the terms of this Deed of Trust and the Rules and Regulations framed hereunder.
3. The Trust shall have the Registered Office at 'Hitha Square' HARSHITHA FARM, VASANTHAPURA MAIN ROAD, VASANTHAPURA, BANGALORE - 560061-KARNATAKA, INDIA.
4. The property of the Trust shall include.
 - a. A sum of Rs. 5,00,000/- contributed by the Chairman.
 - b. Such contribution, donations, endowments, settlements made by the Trustees, the Public, Government Institutions, the Government (State or Central) and other bodies, Corporate and the like for the purposes of advancement and implementation of the objects and purpose of the Trust.
 - c. Such acquisition and accretion to the estate of the trust as any be made by the Trustees.
5. The properties, the assets, the effects, the funds and the like of the Trust shall vest with the Trust perpetually and irrevocable for the due fulfilment and effectuation of the objects, purposes and developments of the Trust.

THE AIMS AND OBJECTS OF THE TRUST SHALL BE:

- I. To promote EDUCATION without any distinction of Cast, Creed, Community and Religion for the education of the Children particularly belonging to backward communities, schedule castes, schedule tribes and minorities to start and run:-
 - a. Early Childhood Education, Montessori, Kindergarten- LKG & UKG, Primary, High School, Pre-University Colleges, Degree Colleges And Training Institutes For T.C.H, B.Ed, and Diploma Classes and Residential Schools, Semi-Residential Schools, Polytechnic, Research Centres in all disciplines, distance education programs/courses and any other courses as may be decided fit by the Trustees.

- b. Technical Education in Engineering, in Medicine, Software, Hardware, Bio-technology, Technical Education, Environment, Agriculture, Animal Husbandry and Post Graduate Courses and any other Courses.
 - c. Training in Fine Arts, YOGA, Vocational Training Certificate Courses, Professional Education and other Training Centres.
- II. To Promote sports, to arrange competitions, Seminars, Exhibitions, etc.,
 - III. To maintain Libraries and Reading Rooms for the benefit of the students, the public and to start Hostels for the students.
 - IV. To undertake Research in Economic Science, Commerce, Technology, Politics, Social Science, Humanities and convey the results of research to the students and other persons.
 - V. To arrange for the maintenance of discipline, Nationality in students and other young persons and encourage the poor students by extending scholars and loan facilities and such other benefits.
 - VI. To open Diploma Courses in Language, Science, Commerce, Literature, Industries, Culture, Medicine etc.,
 - VII. Social Service.
 - b) To start voluntary organisation to avoid social imbalance and to undertake developmental activities in Social Services.
 - c) To undertake social welfare activities for the development of Children of all classes, intellectually and physically
 - d) To undertake activities for the development of the persons living in Urban and Rural area in literacy, adult education, Vocational Training, Training of Blind and the Handicapped.
 - e) To eradicate the social evils existing in the community to stop the child marriages to encourage widow marriages and group marriages, to propagate the family planning and to create social awareness in men and women.
 - f) To undertake activities for the development of the tribal people having no knowledge of civil awareness.
 - g) To promote health and to arrange for the Medical Aid to the persons living in rural areas and hill areas.
 - h) To arrange social gathering, Literary Association, Lecturers and Debates for the benefit of students and others.
 - i) To obtain and secure all available assistance and necessary help of all kinds from Mandal Panchayaths, Zilla Parishaths, Municipalities and Government and any other sources to obtain lands and to construct and maintain old age home for the benefit of aged orphans. The said facilities may also be extended to destitute homes.



- j) To establish, maintain and run hostels for ladies employed or otherwise, for this purpose to acquire lands and construct hostel buildings or to secure suitable modes such as lease, rent or gift etc.,
- k) To support and promote cultural taste among students and other members of the Society, arrange and conduct dramas, musical performance and lectures on the subject of theatre and dramas, paintings, classical Music and Research.
- l) To support and promote physical education and training of all kinds including Yoga, Karate, Wrestling etc.,

VIII. To establish newly or by taking over provide, equip, endow furnish, maintain, develop, control, manage and conduct hospitals, in all or any of their departments and functions for providing Medical Surgical, Nursing care or treatment for indoor or outdoor patients and such other institutions as the Board or Trustees may deem it necessary or convenient for any of its purposes of all which are charitable and no activity of any profit.

IX. To provide and cultivate literary activities among all sections of people including students by conducting lectures and by publishing books.

X. To promote charity and undertake charitable activities for the benefit of the disabled, the blind, the widows and other needy persons.

XI. To establish and run orphanages, Destitute Homes, Rescue and rehabilitation Centres, Homes for the working Women and old age persons, to grant donations for the support of the in-mates of such organisations.

XII. To promote Fine Arts like Music, Dance, Janapada and any other cultural activities and to arrange for the training in any fine arts.

XIII. To acquire and to hold movable and immovable properties by any of lease, purchase, gift, mortgage or otherwise and to improve and to allocate by way of sale, mortgage or otherwise.

XIV. To collect funds by way of Subscriptions, Donations, Contributions, and to raise Loans secured and unsecured from any scheduled bank and financial institutions or firm or individual and /or any other Registered Society or Trust or N.R.I with or without interest as and when necessary for fulfilling the objects of the Trust.

XV. To undertake any such projects as may be conducive to help the above said objectives.

XVI. To start and run the Training Institute of Dairy, Fisheries, Nursery and other Colleges and Home Industries to encourage unemployed person living in Urban and Rural Areas.

XVII. To start and run Homeopathy, Ayurvedic and Naturopathy centres, hospitals training centres and institutions.

6. **BOARD OF TRUSTEES:** The Management of the Trust shall vest with the Board of Trustees, Constituted by the Trustees mentioned herein above who shall be the first Board of Trustee.

7. The Quorum of Trustees shall have authority to co-opt additional Trustees not exceeding Four.
8. The vacancies caused by way of death, resignation or for any reason shall be filled in by the remaining trustees any person deemed fit by them.
9. **INVESTMENT:** The funds of the Trust shall be invested in the modes specified under the provisions of sections 13(1) (d) read with Sec 11 (5) of the Income Tax Act 1961.
10. It is hereby declared that the Trustees have power to wind-up this Trust by merging or amalgamating with any other Trust or Charitable Society having the same or similar objects, if the Trustees decide that the objects of this trust would be better served by taking such a step.
11. **MEETINGS:**
- The Board of Trustees may meet at any time when required for the business of the Trust and shall meet at least once in three months.
 - The Quorum for the meeting shall be two in number. No proceedings shall be started without a Quorum. If there is no Quorum within half an hour fixed for meeting, the meeting shall stand adjourned to next week of the same day, the same hour and place and discuss the subject of the Agenda, once again by the Trustees present. If such a day is inconvenient to the meeting the meeting may be adjourned to the next convenient day.
 - A notice of at least 7 days shall be given to call the meeting of Board of Trustees; but in emergent circumstances, a meeting may be called by giving a short period. The Secretary shall have authorized to call the meeting in consultation with the Chairman.

12. **FINANCIAL YEAR:** The Financial and Official year of the Trust shall be from 1st April to 31st March of the succeeding year but to start with 31st March 2016 shall be the year end.
13. **FUNCTIONS:** Without prejudice to the generality of the powers, the Board of Trustees shall have the following powers and responsibilities.

- (a) To lay down policies with regard to the running of the educational Institutions and other work pertaining to the administration of the Trust prudently and efficiently in the interest of the Trust.
- (b) To accept Gifts, Donations or Contributions in so far as they are not inconsistent with the objects of the Trust and all such Gifts, Donations and Contributions shall form part of the corpus of the Trust.
- (c) To incur expenditure necessary to conduct the activities of the Trust.
- (d) To employ Professors, Teachers, Clerks, Agents, Bankers, Lawyers, Accountants, other employees and workers on such remunerations as the Board may think fit, and to suspend, punish, dismiss or discontinue their services and to determine their duties and remuneration and / or allowances etc.,
- (e) To arrange for periodical stock taking of the assets of the Trust.
- (f) To withdraw any power or to revoke any appointment of any employee or attorney or others.
- (g) To invest Trust money with the banks, Govt. Securities of any other investments as provided for in Sec. 11 and 13 of the Income Tax Act 1961.
- (h) To convert call in, sell or otherwise dispose of any of the investments comprising of the Trust Property and re-invest or change the nature of any other investments contained therein.
- (i) To construct or to get constructed the building required by Educational Institutions and / or by the Trust and to develop and to make alterations in respect of these buildings.
- (j) To appoint Sub-committees for specific work and to entrust any duties of the Board of Trustees.
- (k) To maintain bank accounts in the name of Trust and to operate the same, along with the CHAIRMAN any one, either SECRETARY or TREASURER will be authorised to sign the documents/Cheques.

- (l) To pay all taxes, cost and expenses incidental to the management, production, preservations and maintenance of Trust property and income thereof.
- (m) To institute, prosecute and defend all actions and proceedings before Govt. Courts, Tribunals, Revenue, local Municipal, Postal, Railways, Taxation authorities etc., including appeals, executions and like to represent the trust before them.
- (n) To frame amend, Annual Subsidiary Rules for the conduct of the activities of the Trust and service rules for the employees of the Trust.
- (o) To keep proper accounts of the receipts and payments of the Trust through the Secretary as early as possible after the close of the year on 31st March, to prepare the annual statements of accounts and to get them audited by a person authorized to audit the accounts of the companies register in the state of Karnataka under Sec. 226 of the Companies Act of 1956.

16. **CHAIRMAN:** The Chairman shall be head of the Trust. He/She shall have authority to supervise the affairs of the Trust to preside over the meetings to advice the other office bearers and in case of emergency to call for the meetings.

17. **TREASURER:** The Treasurer shall have authority to Supervise the Financial matters and to operate the Bank accounts as per the decision of the Board of Trustees.

18. **SECRETARY:**

- a) The Secretary shall be the Chief Executive Officer of the Trust and he/she shall have the following duties and responsibilities.
 1. In consultations with the Chairman, to convene the meetings and record the proceedings.
 2. To implement the decision of the Board of Trustees.
 3. To supervise preparation and presentation of the Annual Budget and Annual Accounts.
 4. To collect rents and all other incomes of the properties of the Trust.
 5. To expand the activities of the Trust and the Institutions connected with the Trust.

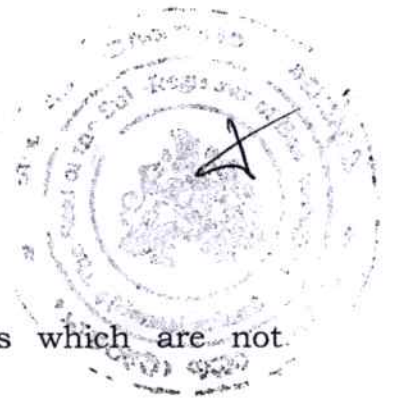

6. To appoint the staff on purely temporary basis.
7. To take suitable steps in emergency matters which are not mentioned above in the interest of the Trust.

(b) The secretary shall be the custodian of books of accounts records and all the properties including the cash.

21. **BANK ACCOUNTS:** The Board of Trustees shall open bank accounts in the name of Trust and to operate the same, along with the CHAIRMAN any one, either SECRETARY or TREASURER will be authorised to sign the documents/Cheques.

22. **INDEMNITY:** The Trustees shall, at all-time be indemnified in respect of any act that they might have done bonafide and in good faith in respect of matters relating to the Trust and they shall not be entitled to any remuneration except travelling and other expenses actually incurred by them in doing the work of Trust.

23. **AMENDMENTS:** NO amendments to the RULES shall be made which may prove repugnant to the provisions of Sec. 2 (15) 11 to 13 and 80 of the Income Tax Act. 1961. However, no amendments shall be carried without prior approval of the Commissioner of Income Tax, if the Certificate under Section 80 G of the Income Tax Act is obtained.

25. The funds and Income of the Trust shall be solely utilized towards the achievement of the objects and no portion of it shall be utilized for payment of Trustees by way of profit, interest, dividend etc.,

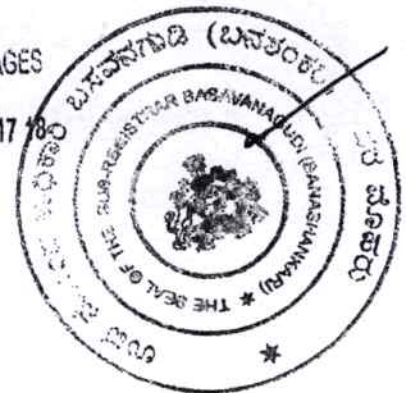

SUPPLEMENTAL AMENDMENT TO THE TRUST DEED

This Amendment is made at Bengaluru on this 12th day of March 2018 by Harshitha Krishna, w/o Dr. V N Kamalesh residing at Harshitha Farm Vasanthapura Main Road Vasanthapura Bangalore-560061, Radhika N, d/o Late B V Narayanan Swamy residing at # 62, 3rd Main, Kattriguppe East, Banashankari 3rd Stage, Bangalore-560085 and B V Premakumari, d/o Late B V Shamanna residing at # 46, Ranga Rao Road, Shankarapuram Bangalore 560004, hereinafter called the 'TRUSTEES' WITNESSETH AND DECLARES AS FOLLOWS :

WHEREAS a Public Charitable Trust by name 'SRI KRISHNA INDIRA EDUCATIONAL & CHARITABLE TRUST' was brought into existence on 30.10.2015, by means of a Deed of Trust, registered as Document No.260 of 2015-16 of Book IV in the office of The Sub Registrar, Basavanagudi (Banashankari) Bengaluru, Karnataka.

WHEREAS the Trustees now further feels that certain changes in the Existing and New Clauses have to be incorporated in the Trust Deed.

NOW THEREFORE THIS SUPPLEMENTAL DEED witnesseth and it is hereby agreed between the parties as follows:
